Recently, the State of Vermont and the Local 4802 of the American Federation of State, County, and Municipal Employees (AFSCME) Council 93, negotiated a new Collective Bargaining Agreement (CBA). AFSCME represents independent direct support providers, including Developmental Disabilities Services providers.

## With the pay period beginning July 3, 2022, a new CBA, with an increase in the minimum wage, will go into effect.

Employers must continue to calculate **11.38%** as the tax rate for ALL employees, no matter the wage they are paid.

Based upon the new CBA, the minimum wage will increase to \$13.44 per hour. The new total hourly rate that you must budget for (to include taxes) is \$14.97 per hour. The new minimum

daily rate increase to \$215.04 per day. The new total daily rate that you must budget for (to include taxes) is \$239.51per day.

If you submit a timesheet that includes a rate below the minimum required, ARIS is authorized by the Department to adjust the rate to the minimum required.

The authorized rate and the amount you decide to pay your workers may not be the same. Only those whose authorized budgets are **below** the required minimum will receive an increase related to the CBA. Your agency will notify you of the increase in the Authorized Funding Limit (AFL).

DS agencies and Transition II will receive additional funds to increase the budgets so that individuals may still access the same number of hours of service. DS agencies and Transition II will receive additional funds for individuals whose *authorized* budgets have rates below the newly required minimums.
